"So... I got this check in the mail, now what?"

You check your mail and discover a check for \$1500. You do not recognize who it is from and you definitely were not expecting a check of that size. What now?

First things first, call your financial institution. They will give you instructions on what you need to do next. More than likely, that check is fraud.

Just because the check is deposited does not mean the funds are verified and the check is good.

Fake checks are very hard to identify. Due to the increasing capabilities of graphics and printing technology its never been easier to create realistic looking checks. Its best to alert your financial institution, so they can impose a hold on the funds until the check is verified as good. If a check comes back as fraudulent and you have already taken the funds, you become responsible for paying back your financial institution. Remember to follow your gut and if it seems too good to be true, it probably is!

just need to have the taxes prepared by a reputable tax preparer and list your account number and our routing number on your return. Our rates are guaranteed to be less than you'll find elsewhere.
