Debit Card Fraud Alerts

Our card monitoring service is continuously looking for debit card transactions with a high likelihood of fraud. If a transaction is flagged the member will be called, texted, or emailed. If the member confirms they completed the transaction then nothing more will happen. If the member does not reply or indicates that they did not complete the questionable transaction then their card will be made inactive. The card will remain inactive until they contact the credit union or a new card is ordered. It is important for members to keep their phone and email information with the credit union up to date to prevent these alerts from being undelivered and cards from being shut off.
